

2024 BUDGET

The Cochrane Lake Gas Co-op Ltd. (CLGC) 2024 Budget was approved by the Board. Overall, operating revenue is up year over year by 4.15%. Operating expenses are up 4.24%.

To provide adequate revenue to cover expenses, the Variable Gas Rate was increased from \$2.04/gigajoule to \$2.10/gigajoule effective January 1, 2024. The fixed rate remained unchanged at \$29.50 per month, as did the Facility Upgrade Surcharge of \$10.00 per month. For a customer using 150 gigajoules of natural gas per year, this results in an annual increase of \$9.00 per year.

The following graph demonstrates where your money goes. The graph is based on each dollar spent by a member.



Based on the above graph, 38% of your dollar spent represents the cost of distributing gas to our members, 25% is the wholesale natural gas cost, and 37% is the federal fuel surcharge and GST.
